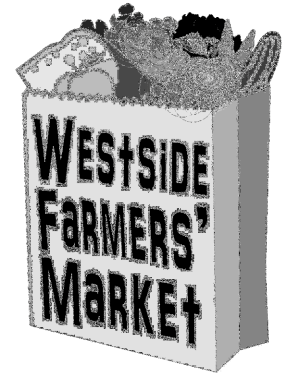

After completing this on-line application, you will receive a confirmation number of your electronic submission. You can receive your new Sales Tax License in as little as 7 business days!
